Looking forward to your continued participation in all activities of VCCI and with best regards, ON BEHALF OF TEAM VCCI 2018-20



VCCI Year Round-up

The year went Eventful. Apart from regular executive committee meeting, few seminars, international business trip, felicitation and service projects were done during the year.

The year started with VCCI AGM at Four Points Sheraton, 120 members attended the AGM.



During 2016-2017 the following seminars were conducted by VCCI

Visit of Katherine Hadda, U.S. **Consul General**

Consul General of US Consulate in Hyderabad, Katherine Hadda and Minister Counselor for Commercial Affairs at the U.S. Embassy in India, Patrick Santillo visited Vizag and attended a small dinner hosted by VCCI at the East Point Golf Club.



VCCI is the American Business Corner partner of the US Consulate.

A brief introduction of VCCI was followed by a mention of the business climate in Vizag, Smart City programs and the commercial activities conducted by VCCI over the past year. Since this was the first visit of Minister Counselor Santillo to Vizag, he introduced himself and made brief remarks along with CG Hadda.

ANDHRA PRADESH **PRIORITIES**

The Copenhagen Consensus Centre which in partnership with the Tata Trust launched the Andhra Pradesh Priorities Project. The aim of the Project is to provide the State Government and the development community with a systematic process to help prioritise the most effective development solutions. VCCI arranged holding 2 roundtables on Andhra Pradesh priorities in Vizag.

- 1. First Roundtable discussed issues related to ease of doing business, low total factor productivity and problems related to MSME sector etc.
- 2. The Roundtable on Transport discussed issues of absence of multi-nodal logistics hub, poor connectivity due to road infrastructure, opportunities to expand port facilities for expansion of trade to the east etc.

Dr Brad Wong, chief economist, Copenhagen Consensus, presided along with senior management of TATA Trusts and Copenhagen Consensus. VCCI invited a cross section of citizens from business. Government and academia to participate in the round tables.

DIGITAL MARKETING

A workshop `Secrets of Digital Marketing` was organised with Ms. Sangeetha Abishek. She spoke on

How social media could affect business and how the decisions business owners took could affect how the business performed. Ms. Abhishek said that regardless of whether one sells products or services out of a storefront or online, owners have the potential to build a strong social media presence that will help the business to grow and connect with its audience, convert more leads into actual customers, and get those customers to refer their friends and colleagues

Social media is one of the most costefficient digital marketing methods used to increase business' visibility. In order to help small entrepreneurs especially ladies running small businesses. The event was well attended by small entrepreneurs and lady entrepreneurs.

HKTDC and VCCI held a seminar at TAJ Hotel, Visakhapatnam various subjects like
